INTRODUCED BY RAYMOND FRENCH, STUDENT BODY PRESIDENT; MEGHAN
CHARLIER, STUDENT BODY VICE PRESIDENT; AND DAVID MCCARTHY, TREASURER

1 **WHEREAS, the members of the Student Senate Executive Board are currently**
2 **given a stipend from the student body's segregated fees, allocated to Student**
3 **Senate; and**

4 **WHEREAS, the stipend serves as payment for the work done on behalf of**
5 **the student body; and**

6 **WHEREAS, the President's stipend at UW-Eau Claire and other University**
7 **of Wisconsin institutions is traditionally comparable to tuition; and**

8 **WHEREAS, traditionally, the stipends are based as a percentage off the**
9 **President's stipend; and**

10 **WHEREAS, the stipends were last increased in the 47th Session; and**

11 **WHEREAS, tuition has increased considerably in the last four years; and**

12 **WHEREAS, raising the stipends would decrease the need for those in paid**

13 **positions, such as the President, to have a second job, which only takes away**
14 **time that could be best used serving students; and**

15 **WHEREAS, Attachment “A” describes the current and proposed stipend**
16 **policies;**

17 **BE IT THEREFORE RESOLVED that the UW-EC Student Senate approves**
18 **the stipend changes on Attachment “A;” and**

19 **BE IT FINALLY RESOLVED that upon passage, these changes take place**
20 **beginning in the 52nd Session.**
