CLASSIFICATION APPOINTING KATHERINE MICHELLE FAUST AS AN
ASSOCIATE JUSTICE OF THE STUDENT COURT

INTRODUCED BY DYLAN JAMBREK, STUDENT BODY PRESIDENT

1 WHEREAS, Article IV, Section H of the Student Body Constitution requires
2 a judicial appointments committee meet and recommend candidates to the
3 Student Body President for appointment; and

4 WHEREAS, the Constitution provides for a no more than three year
5 appointment to the Student Court; and

6 WHEREAS, the Court will oversee all Constitutional issues, appeals of the
7 student government, and oversee the Student Senate elections; and

8 WHEREAS, the committee has nominated Katherine (Katy) Michelle Faust
9 for the position of Associate Justice of the Student court; and

10 WHEREAS, Section H requires all court appointments to be in the form of a
11 bill with the justifications listed for the appointment; and

12 WHEREAS, this bill must be approved in a majority vote to pass and

13 **appoint the Justice; and**

14 **WHEREAS, Katy Faust is a sophomore Political Science (Legal Studies**
15 **Emphasis) major; and**

16 **WHEREAS, Katy Faust was recommended by Professors Faith Pawelski**
17 **and Jasmine Krotzman; and**

18 **WHEREAS, Katy Faust served in high school student government, as the**
19 **Towers South Judicial Board representative, as the current chair of her sorority's**
20 **Honor Council; and**

21 **WHEREAS, Katy Faust has worked on a research project with a local**
22 **Circuit Court judge, is a member of the Pre-Law Club and Criminal Justice**
23 **Association; and**

24 **WHEREAS, upon review President Jambrek has agreed with the**
25 **committee's recommendation;**

26 **BE IT THEREFORE RESOLVED that the Student Senate confirms President**
27 **Jambrek's appointment of Katherine Michelle Faust as Associate Justice of the**
28 **Student Court; and**

29 **BE IT FURTHER RESOLVED that this appointment take effect at the end of**
30 **the meeting of this bill's passage; and**

31 **BE IT FINALLY RESOLVED that upon passage, President Jambrek transmit**
32 **a copy of this bill to Dr. Brian Levin-Stankevich, Chancellor; Dr. Patricia Kleine,**
33 **Provost/Vice Chancellor; Dr. Beth Hellwig, Vice Chancellor, Student Affairs; Dr.**
34 **Brian Carlisle, Dean of Students; Dr. Susan Harrison, Chair, University Senate;**
