### Pros (Discussion)

**Student** ~ anxiety & frustration especially because this situation is atypical and because other institutions have already adopted a policy

↑anxiety due to economic and job outlook will impact ability to focus on academics

Opt-in option provided at the very least and detail explanation for whatever policy is adopted

Online delivery was not what they paid for and therefore should be provided more option when the academic semester resumes

Academic performance will suffer dramatically because students are unable to take advantage of faculty/IAS office hours, tutoring, and student led labs

**Faculty** ~ some students don’t have reliable access to the internet and/or technology for remote/online learning (e.g. rural, no access to PC/Laptops and will rely on smartphone devices). These students deserve an option of S/U

Some students have taken on the economic burden caused by the COVID-19 pandemic due to parental job loss and now are the primary financial providers in their household. This will

negatively impact their academic performance via remote/online learning. These students deserve an option of S/U

Favors a mandatory not optional temporary grading scheme (S/U)

#### Cons (Discussion)

**Faculty** ~ Undergraduate courses at UWEC are taught by faculty/IAS rather than graduate students and this may afford the university a unique ability to handle the transition to online instruction

Adoption of S/U policy will add to the anxiety that students are already feeling about the resumption of the spring semester. Students should be provided the opportunity and/or be expected to perform well academically (assuming support services are in place/adequate) as much as possible during this atypical semester.

Adoption of S/U policy reinforces the notion that students won't be successful, so an escape hatch must be created

Could other alternatives be considered beside adoption of S/U policy adoption?

#### Draft Policy

Initial Statement to Students (Sent 4/1/2020; drafted by Evan Weiher & Marquell Johnson)

Representatives of UWEC Faculty and Instructional Academic Staff are aware of the petition to have all UWEC classes become satisfactory/unsatisfactory grades when the academic semester resumes next week. UWEC Senate Executive Committee and Academic Policies Committee are considering the potential advantages and disadvantages to students as this approach is more complicated than it may initially appear when applied across majors and departments. Additional information will be forthcoming from shared governance regarding a potential policy change.
