REPORT: President – Charlie Johnson – johnsoch0968@uwec.edu

Last Tuesday, I attended the April University Planning Committee meeting where we discussed where we are in the planning process, in light of the pandemic, and what the next steps of the plan will look like. I was also able to attend our monthly check-in with Vice Chancellor Haven. On Wednesday, Vice-President Ziebell and I had a call with the Chancellor to check-in and see how things are going. We will be having our regularly scheduled monthly check-in with the Chancellor this week. I also attended the Sonnentag Project messaging strategy meeting where it was officially conveyed that the project would temporarily be put on hold. The Project partners, which include the University, the Foundation, Mayo Clinic, Visit Eau Claire, and the City of Eau Claire all agreed it was best to make this decision. This information was conveyed to the Student Body on Friday morning in the email I sent out. On Wednesday afternoon, Stephanie Pyykola and myself met with Daniel Botting from the Andrew Goodman Foundation to discuss entering into a partnership. The Andrew Goodman Foundation is a non-partisan organization focused on engaging student civic leaders at colleges and universities across the country. They provide mentorship, yearly grants, a University tailored page on myVoteEverywhere.org, resources,



peer to peer learning opportunities, and much more. A memorandum of understanding is being provided to University Legal this week and it is my hope this can be finalized sooner rather than later as election season is already upon us. I was also able to have a call with City Councilman Jeremy Gragert just to check-in and see if there was anything he could assist with. On Friday I attended the weekly COVID-19 communications meeting, and in the afternoon I took part in interviews with both WQOW and WEAU regarding the Sonntag Project, and Satisfactory/Unsatisfactory grading.

Academic Affairs Commission Director – Travis DuChene – duchentl0349@uwec.edu

This week I met with the provost to discuss the state of Academic Affairs. We discussed the budget of academic affairs. There have been a variety of unexpected costs within academic affairs including upgrading contracts with online providers, paying for domestic student's travel and board until they arrive back in the States, and providing resources to students who do not have access to devices or reliable internet access. We have exhausted a lot of our savings, but the budget is still looking fine. However, after reviewing the data gathered from the chairs meeting, it appears that all students except twenty have been in contact with their professors within the first week of online courses. Most professors are receiving positive feedback despite a few technical barriers that need to be overcome. The provost and I also discussed the possibility of the University moving to online classes. It appears that the UW system will be making that announcement by July 10th, 2020. However, UWEC is already making preparations in case we do move online in the Fall. Department chairs were instructed to consider going online. Some departments have unanimously decided to move online for the Fall while others are allowing individual professors to make the choice. After attending the UW System Reps meeting this weekend, it appears that most other UW system universities are making similar preparations. Lastly, APC has officially drafted an Opt-In S/U policy and it has been presented to the executive board of faculty senate. The policy is very



different than the one explained at last week's meeting. The Opt- in S/U policy will need to pass university senate and then it will become an official policy of UWEC. However, this doesn't mean that all students immediately get the option of an S/U in any of their courses. Instead, the department/ college will have to decided whether they want their majors to have the option to partake in the Opt-in S/U policy. If the department/ college decides not to offer it to their majors than those individuals will not have the option for an opt- in policy. If the department allows those students, the option to partake in the Opt-in S/U policy than they can and a COVID-19 S/U will appear on their transcript. However, each student will only be given the S/U option for 12 credits for their academic career at UWEC. Therefore, this policy is not as student oriented as was originally planned and the current policy will actually act as a barrier to students and limit the number of students that will even have access to this policy.

I would also like to apologize that the Communications Commission has not been reached out to yet, I was planning on doing it within the past three days but a family emergency arose and I needed to leave town to support my family. “This past week, Governor Evers extended his Safer-at-Home Order until late May; protests against this measure have been reported in Milwaukee as well as the Capitol Building in Madison. Earlier in the week, the results of the April 7th election were compiled. The statewide Marsy’s Law referendum passed; in the Eau Claire area, the CVTC referendum passed, which is a part of a larger trend of supported education referendums throughout the state of Wisconsin.

Wisconsin Air National Guard has received a squadron of new fighter jets, F-35s, which will be stationed at Truax in Madison. While neat from a technological standpoint, these jets do bring the drawbacks of noise and pollution. Both Wisconsin Senators have commended the decision.”
