Last week, President Johnson and I were able to hold our monthly meetings with the Chancellor and Provost Kleine. I was able to attend the Facilities Auxiliary Assessment meeting on Wednesday, as well as a Budget Strategy Discussion meeting on Thursday with shared governance and executive staff. Other than an additional Budget Strategy meeting this coming Thursday, this week is much lighter. I want to take this time to address some of the confusion we've encountered these past few weeks. First, I want to acknowledge the uncertain time and situation we all have been experiencing. Balancing online courses, student government, and our personal lives during this global pandemic has not been easy. Our ways of attempting to conduct normal Student Senate business is difficult and imperfect. With security issues surrounding Zoom—acknowledged even by the FBI—and the discussion of accessibility, it has been hard to completely navigate this uncertain situation. I acknowledge the shortcomings when it comes to communication and I have begun preparing for this summer. I've exploring avenues of continued communication to this body, as well as the student body. As a student leader, I want to ensure that clear communication and timely information for everyone is my top priority. Other than the accessibility aspect that we had technical issues with, we were able to follow all other distribution notices. That includes giving a 24-hour notice of our meeting and what we are discussing, notifying our campus media, and posting all meeting minutes, agendas, and legislation onto our website in a timely manner. I am pleased we will have a chance to ensure the important legislation so many of you have worked on is properly considered tonight. I would like to express my immense appreciation and thanks to President Johnson, Director Miller, Director Rush, and Senator Angelo, as this is their last meeting and they are graduating. They all have contributed so much to this organization the past few years. You have left such an impact on my experience with the Student Senate and your leadership will be greatly missed. Working with each of you has been an honor and I wish you all the luck in your future endeavors.

REPORTS: Board of Directors

Academic Affairs Commission Director – Travis DuChene – duchentl0349@uwec.edu

The University Senate Executive board unanimously passed the proposed S/U policy and has now made its way to the Provost's Office where it will be implemented. As you all saw from an email from the Chancellor today, we should be hearing more information on this topic soon. If you want to view the draft of this policy, please feel free to view on the University Senate webpage, as it is public record. I have continued to do research on how Satisfactory/Unsatisfactory and Pass/Fail systems will impact admittance into graduate school and licensure. As of this moment, very few high education institutions have announced that they will change their admittance policies and if they have it has been very minimal. However, 140 student governments from across the nation, including UW Platteville, signed a letter appealing to national high education organizations, like the Association of American Universities and Council for Graduate Schools, to make changes to their admittance policies. The CS Task Force met to discuss its future. The group unanimously decided that the program still wasn't in its desired condition given that new faculty have not arrived on campus yet and that plans to change the composition of the major have not been enacted. In accordance with the Student Senate Constitution and the Student Senate Bylaws, the Computer Science Task Force falls underneath the discretion of Director of Academic Affairs and will continue to exist until the appointment of the a new Academic Affairs Director in the 64th Session. The founding document has been updated and edited to accurately reflect the current status of the CS Task Force. Lastly, I was reading some news articles on the status of the UW System as it deals with the COVID-19 pandemic. The UW System announced that it has lost \$170 million dollars in revenue as of the Spring of 2020 because of its response to COVID-19. This huge loss is coupled with the financial



losses at individual higher education institutions that threaten the ability for institutions to remain open. Higher education institutions across the country are struggling to determine how many students will be enrolled for Fall 2020 as students are cautious to engage in another semester of online courses. As of an email from our Chancellor, there is a group of individuals who will be researching which course of action is best for UWEC. Thanks for a great year!

Two weeks ago, the Intergovernmental Affairs Commission met to discuss wrapping up work for this semester. As the commission's responsibilities never truly stop, some members will be continuing work over the summer and presenting it to the commission in the fall. Last week, IGA finished up its semester with one last meeting. I'll now briefly recount some of the successes of the IGA Commission this past year: we collaborated with city partners to organize Eau Claire's annual International Peace Day event; we held an amicable block party with the Historic Randall Park Neighborhood Association; we established a relationship with the Economic Development Department of the city of Eau Claire; we supported local Hmong leadership organizations and stood at City Hall against the national deportation order; we started research on off-campus housing in the Eau Claire student neighborhoods; we revamped our voter registration plans and materials; we worked in a task force aimed at creating high-profile events on campus, which includes political candidates, and ensured the presence of Safe Spaces during these events; IGA also generated several pieces of legislation during the 63rd Session, and was/is involved with several other projects. Next year will be important for the Intergovernmental Affairs Commission; in the fall semester, a presidential election will be taking place in November. Considering current national trends, the US is very partisan, and western Wisconsin – historically a swing region of a swing state – will be highly contentious and fought over by the two parties. Next fall, we can expect a large presence of in-person and online advertising of the candidates. In the spring semester, Student Senate will have our bi-annual Rally for Excellence during a budget year, making our advocacy on behalf of UWEC students incredibly important. Also, in my personal experience with other organizations, I've found that providing some historic insight and institutional knowledge, along with the responsibilities of a position listed in the bylaws, forged through precedence, pays off well. I'm currently in the process of creating transition materials for the next director, and I encourage all other directors to do the same.

The S.O.S. is one of our nine commissions. Our primary goal is to allocate roughly 186,000 dollars of student segregated fees annually towards sustainable initiatives that benefit UWEC students. We define sustainability at the intersection of community well-being, environmental health, and prosperity. Within the 2019/20 Term, the Student Office of Sustainability: Passed 21 allocations through our body, resulting in a total of \$134,221.05 allocated.

- Continued our partnership with the **City of Eau Claire**, increasing access to alternative forms of transportation - including but not limited to bikeshare and scootershare programs.
- Continue our partnership with **Innovation Labs** as we built a concrete design for the UW-Eau Claire Student Office of Sustainability's Energy Dashboard - an feat estimated to take 3 years.
- Established a partnership with Sustainability in **Housing & Residence Life** through the Zero Waste Series, Welcome Week Waste Training, and RA training.
- Established a partnership with the **Office of Multicultural Affairs** through collaboration and funding of the Latinx Cultural Center's retrofit.
- Continued our partnership with **Parking & Transportation** to provide Zimride ridesharing capabilities to our students.
- Established a partnership with **Orientation** which allows us to provide informational materials to Orientation Assistants.
