**Misc. notes:**

**Introduction:**

- In order to make the Sonnentag Center LEED certification fall under 820 policy, we had to involve students, and this is how we did it
- The class was made free last year, but the exam is not paid for
- This bill will pay for up to 85 students/year
- Removes the financial barrier to receiving this accreditation
- Q: Is there an application for the 85 students? A: Anyone can sign up for it, go to the Administrative Office of Sustainability’s workshop. There is also a class that will help you with the test.
- Q: Is it 85/semester or 85/year? A: Per year
- Q: How many students are currently enrolled in the class? A: 27
  - Followup—If you don’t hit the cap of 85 this school year, does it roll over? A: Answer from the gallery, Lily Strehlow—we intend to keep this project moving forward in future years, hopefully through the summer
- Q: Do you need to be recertified every year? If so, will there be attempt to offset that cost? A: Once certified, you do need to do continuing education credits which are widely available, range in prices, and fairly easy to keep up with.
- Q: Are there prerequisites for this class? A: No
- Q: How long before you need to recertify? A: Indefinite as long as you keep up with continuing education credits.

**Speaker sentiments:**

- Will be voting up; great opportunity to get real life experience and is good for employment.
- It is important to remove financial barriers, especially since we have already started that process with the class.



- It is promising to see this move towards equity and sustainability on our campus.
- Personally didn't take the class because of the 100 fee, so removing the fee is important.
- If we already passed LEED for the Science Building, it is in our best interest to allow more hands on experiences for students at UWEC.

**Misc. Notes:**

**Introduction:**

- Author got involved in order to engage the student body.
- We discuss many important topics here worth sharing.
- This was originally a bill, but after consultation with the VP and Parliamentarian, thought best to change to a resolution.
- This will add language to the Student Senate Operating document, so it is non-binding, simply recommendations.
- Last year livestreamed all GA meetings for Towers Hall council, which was successful.
- We already livestream on Facebook, so why not on Instagram as well, as it is a more popular platform.
- Q: Do you have a proposed way of streaming to Instagram? A: Would hope to work with VP Johnson and Parliamentarian Miller to organize, possibly with Streamyard to stream simultaneously—otherwise could be done from a phone and a laptop.
- Q: Can you explain line 11? A: We have the highest student voter turnout out of any UW, so it shows that our students are engaged and want to be involved, can increase this percentage further, which benefits everyone—if we give more notice/availability can translate to higher voter turnout.
- Q: On line 18-20, any concerns on the length of our meetings being hard to host? A: When you livestream on FB and Insta, there is an option to post it immediately after, no matter the length; was not an issue for Hall Council, hope to work with the President and Parliamentarian to include more details.
- Q: If a meeting runs long, is there a way to shorten that video for students looking for more information? A: Open to the suggestion, those details can be worked out, this is simply to encourage it happening.



- Q: Was Comms consulted before this resolution? A: No, did not think it required it since livestreaming is relatively easy—is willing to work with the Comms director on this and anything that they would like to see implemented.
- Q: Would it be possible to post meeting summaries on our Instagram Story? A: Sure, willing to implement/work on that, every meeting should have something posted, whether a summary or video.
- Q: Would this hinder our ability to start a meeting, as this has been an issue in the past? A: No, because it is not a bill, as a resolution it is simply advisory, so if Facebook or Instagram is down, it would not prevent us from starting.
- Q: If Instagram becomes extra work (e.g. editing, advertising) who would do that work? A: As of now, if we take the route of a multistreaming platform like Streamyard, it would be no more difficult than what we already do.
- Q: Do you have the citation of the study mentioned in line 8? A: Do not have that citation right now—can provide it if asked.

#### Speaker Sentiments:

- **AMENDMENT:** line 19—correct the spelling of the word “meeting”
- **AMENDMENT:** line 19, change “on both platforms” to “on the Student Senate Webpage and the Student Senate Facebook page” **Passes: 29-2-2 via placard**
  - Removes Instagram from that specific list, posting GA to Instagram is not conducive to longform videos.
  - The change to the webpage makes sense, as it is the central hub of all our information.
  - Can refer to Instagram through FB
  - Posting on our Instagram more than we do would oversaturate the stream
  - After hearing others perspective, supports this amendment, would be beneficial to other students to be more exposed to our meetings
  - Echo previous sentiments, while the speaker appreciates others’ comments and feedback, will be voting to keep the original language
  - Instagram would be a good resource for livestreaming, but not best for hosting long videos, difficult to navigate—perhaps short clips on Insta would be better, and links to the full videos
  - Likes the suggestion, but as the resolution only talks about FB and Insta, perhaps a second resolution would be prudent for the Webpage
  - This is nonbinding—if issues arise, we can cross that bridge when we get to it, right now our biggest issues is that we don’t engage enough—this is step 1 to provide information to begin with
  - Agree with the original language as well
  - Can be overwhelming to have the same notification in several different places—recaps would be better suited to Instagram stories, can link it to Student Senate webpage
  - Considering that there are lots of concerns to be answered, would like to move the matter to Comms Commission for further review



- To clarify, this amendment is just to POST on Instagram—this amendment does not change livestreaming on both, just where it would be posted. This is to revive a past practice, to make a short summary post, a minutes of the minutes to recap the meeting and led to links to watch the whole meeting. Once again, this just changes where the entire recording would be posted after recording
- As a Communications member, will be voting this amendment up—this is nonbinding
- Can't vote, so will not be voting— but likes what the amendment is going for. If on the website, it is a good way to document this session. To have the recordings on the website overall for future sessions to reference is important, can't necessarily get long-term storage out of Instagram, which may not be permanent; we have more control over the website.
- If we did post the full length videos, it would be oversaturated and overwhelming
- **AMENDMENT**—line 24, remove “post”
- **AMENDMENT**—line 24, strike “, including” and “and”
- **MOTION** to refer the resolution to Comms for further review: **Standing vote, passes 29-2-2**
  - **MOTION** for a standing vote: **23-8-2 passes**

#### **Speaker Sentiments**

- Likes the idea, but some of the wording is too wordy or confusing—would be good to go through a commission.
- Echo previous speakers, there are parts that could be changed, a commission could do that easily, and since comms handles our media, they are best equipped to handle it.
- In agreement—important to pass it properly, make sure everyone is involved who needs to be.
- This is to add to the Operating Policies document, this is not the policy that will go forward, this is to encourage Parliamentarian and Vice President to add this clause to a document that is very fresh, exists in this session alone—this is a step forward in what we as a body would want to put forward in this document. Upon passage, these conversations could be had going forward, this resolution is just a step one.
- This is nonbinding, it is important to clarify, with the commission that would be handling this, it is important to have input from the author facilitated through comms, as they have the best understanding of what is effective/possible
- Establish that this is just a statement, appreciate the feedback, want to stress that this is just a recommendation—this is a call for efforts to be made
- Agree with previous statements, this should be moved to Communications, likes that the author states that they would go to Communications, better to handle these edits through Communications.
- The fact that we are not currently streaming on Instagram, given that we are a college campus is a bit alarming, acting with both in mind is leaving a lot off the table, the resolution opens the door to more students
- Because this goes on the record, good to be looked over.
- Should look into other platforms not under Meta.
- By referring to Communications, we can make it as good as possible before sending.



- Given the amount of time allotted to this tonight, we should put through Communications to ensure it is refined.
