2025- 2026 Federal Direct Graduate PLUS Loan Application

The Federal Direct Graduate PLUS Loan is available to Graduate students who are enrolled at least half-time at UW Eau Claire. Loans disbursed after July 1, 2025 have a fixed interest rate of 8.94% with a 4.228% origination fee. Repayment begins six months after you graduate, leave school, or drop below half-time enrollment.

An active Graduate PLUS Master Promissory Note (MPN) must on file with the Federal Direct Loan Program before the loan can be disbursed. If the loan is approved, you will be emailed information on how to complete a Graduate PLUS MPN online at studentaid.gov. The average processing time is 4-6 weeks.

To apply for a Graduate PLUS Loan you will need to complete this form and return it to:
